Position Summary			
<p>The Home Care Packages Program provides older people who want to stay at home with access to a range of ongoing personal services, support services and clinical care that help them with their day-to-day activities. The program is part of the Australian Government’s continuum of care for older people in Australia, providing services between the Commonwealth Home Support Program and residential aged care.</p> <p>Following the principles of Consumer-Directed Care and according to the Commonwealth Department of Health program guidelines, the Care Advisor – Home Care Packages is responsible for the provision of advice, support and care coordination to Home Care Packages recipients (Levels 1 -4). This includes the development of a client directed care plan, based on assessed need and personal goals, and a package of care that promotes wellness and independence.</p>
